- ✓ If you cannot afford the fee, you may apply to have it waived. Complete the Application and Order to Proceed in Forma Pauperis forms and submit them along with the above listed forms.

Once a court order authorizing the marriage of a minor has been entered, you must bring a *certified copy of the Order* to the Clerk-Recorder Marriage Department to obtain a marriage license.
